# The Zerbini Family Circus

The Zerbini family circus under the big top started in the USA in 1992. Before that time, the Zerbini family of circus performers and owners go back over a century. Originating in France, the Zerbini's owned circuses throughout Europe and Africa. Julian Zerbini brought his family to the USA in 1968 working as high wire artists in all the top name circuses.

Unfortunately, in 1991 there was an accident. A faulty wire snapped, Alain fell to the circus ring 40 feet below and was told by doctors, shortly after, he would never walk again. True to his nature, he was not willing to accept this and after months of rehabilitation, Alain decided to give it all he had and opened the Alain Zerbini circus. Then it was a small big top seating 500 people. It has now grown to need a new red and white striped tent with a capacity of just over 1000. Alain's determination grew with the circus and contradicting the doctors diagnosis, he not only managed the circus but also returned to performing.

Viewing the circus show, you may see Alain Zerbini performing aerial acts, balancing acts and his favorite, animal acts. The circus travels over 8 months a year and is a favorite at a number of county fairs, such as Moundville, WV, Lexington, VA, Canton, OH, Harrisburg, PA, Hilliard, Oh, Henderson, NC, Meadville, PA, Zanesville, OH, Kirksville, Mo and Sumpter, SC, just to name a few. With over a decade behind him traveling from town to town and fair to fair, Alain Zerbini knows what the public likes and makes every effort to bring it to them year after year.

The circus show changes in its entirety every year so they can return to the same towns. Alain Zerbini brings dependability and professionalism with him and prides himself on the cleanliness of the circus, equipment and trucks. When you deal with the Alain Zerbini circus you deal directly with the owner, Alain Zerbini. He controls, oversees and manages all parts of the circus from the time they roll into town till circus day is just a memory.

# **Established Policies**

THE FOLLOWING POLICIES HAVE BEEN ESTABLISHED AND AUTHORIZED BY THE BELMONT COUNTY AGRICULTURAL SOCIETY BOARD OF DIRECTORS FOR THE 2017 BELMONT COUNTY FAIR.

\*\* 1. No person shall be permitted to make solicitations of any nature, post or display signs, distribute handbills or advertising material, or sell or distribute free any merchandise, except persons in contracted concession or commercial rented spaces.

\*\* 2. Disorderly people will be removed from grounds and illegally parked vehicles will be towed from grounds at owner's expense. Vehicles are prohibited from parking around the livestock barns.

\*\* 3, NO alcoholic beverages or drugs are permitted on the fairgrounds or in the camping areas. Violators will be removed from the fairgrounds immediately and will not be permitted to return to the fairgrounds the remainder of the 2017 fair. In addition, violators will not be permitted on the fairgrounds or in camping areas for the 2018 fair.

\*\* 4. Concealed weapons are prohibited in buildings on the fairgrounds.\*\* 5. Hand held laser devices, build-up games, helium tanks or helium

filled balloons are prohibited. Violators will be subject to possible dismissal from the fairgrounds at the discretion of the concession manager and/ or the Belmont County Agricultural Society.

\*\* 6. ALL DOGS OR PETS (EXCEPT HELPER DOGS IN USE BY THEIR OWNER AND DOGS BEING USED IN CONTRACTED PERFORMANCES) ARE PROHIBITED ON GROUNDS OR IN EX-HIBITION BUILDINGS.

\*\* 7. Official veterinarian approved by the Ohio Department of Agriculture is Dr. Harold Kemp Large Animal Veterinary Service, LLC.

\*\* 8. All bills must be presented by November 1 or they will not be paid within the fiscal year. All checks not cashed within 60 days will be voided and payment refused.

\*\* 9. The Belmont County Agricultural Society is not responsible for printing errors in the 2017 Belmont County Fair Handbook.

\*\*10. Lost and Found Department is located at the Secretary's Office, located next to the Carnes Center and Main Entrance.

\*\*11. No Refunds – No Rain Dates.

# **Belmont County Agricultural Society Constitution and By-Laws**

(As adopted at the Annual Meeting of the membership, November 29, 2012) CONSTITUTION

#### **ARTICLE I - NAME**

SECTION 1. The Society shall be known as the "Belmont County Agricultural Society".

## **ARTICLE II - PURPOSE**

SECTION 1. The purpose of this Society shall be to promote and encourage agriculture, industry, schools, science, art and other interests of Belmont County, which the Board deems proper, and in the best interest of the community.

## ARTICLE III - MEMBERSHIP

SECTION 1. Any Belmont County resident 18 years of age or older may become a member of this Society by paying annually the membership fee fixed by the Board of Directors. Membership certificates shall entitle the member to whom it is sold admission to the fair as the Board of Directors may determine and to vote for directors at the annual election.

SECTION 2. No person shall pay for or secure more than one membership and that membership shall be for that person. No memberships shall be issued to any entity other than a natural person.

SECTION 3. Membership tickets shall be placed on sale annually beginning Thursday during the preceding years' county fair and shall remain on sale through the first day of the current years' fair. Notice of days, hours when memberships can be purchased and the place where they may be purchased shall be announced in the annual premium list and in at least one newspaper of general circulation in Belmont County, twice during the sale, once when they go on sale and again no less than seven or more than twenty-one days before the sale is terminated.

## ARTICLE IV - BOARD OF DIRECTORS

SECTION 1. The membership shall consist of 21 and no more than 24 elected members. In addition to the elected members, the County Superintendent of Schools and an employee of the Ohio State University Extension Service shall be Ex-Officio Members. All terms for directors shall be three (3) years with one-third of the directors elected annually.

SECTION 2. Any vacancy on the Board caused by death, resignation, refusal to qualify, removal from county or other cause may be filled by the Board until the next annual election, when a Director shall be elected for the unexpired term.

SECTION 3. Any officer or director absent for three consecutive regular meetings may have his office declared vacant by a majority vote of the Board of Directors. Any officer or director who fails to participate in twenty five percent of additional activities may have his/her office declared vacant by a majority vote of the Board of Directors.

SECTION 4. Any director who openly or actively works in any manner detrimental to the best interest of the Society as a whole may be removed from the Board of Directors by a majority vote of the Board of Directors. The director removed from the board by a majority vote of the Board of Directors will not be eligible to seek another term on the Board of Directors.

## **ARTICLE V - ELECTION**

SECTION 1. The annual election of the Board of Directors shall be held on the Belmont County Fairgrounds on Saturday during the Belmont County Fair from 10:00 a.m. until 2:00 p.m. at a location to be announced.

SECTION 2. The President of the Society shall appoint 3 judges and 2 clerks who are members of the Society, but not candidates for election, to conduct the election of directors for the Society according to the Laws and Rules as set forth by the Ohio Department of Agriculture, and to declare the results thereof.

SECTION 3. The Annual election shall be by ballot. Ballots must be marked opposite the name of each candidate voted for.

SECTION 4. Only members of the Society, currently residents of Belmont County and with paid memberships, may vote at the annual election.

SECTION 5. Society members desiring to run as a candidate for the

office of director must have attended at least three regular meetings of the Board of Directors during the current year. Society members must declare their candidacy for the office of director by filing with the secretary a petition signed by ten or more members of the society who are residents of Belmont County, Ohio, at least seven days before the annual election of directors is held. The official ballot shall contain only the names of the candidates who have signed the necessary petition and who have met the filing requirements to be eligible for the election as a director. Blank petitions shall be furnished by the Society and shall be obtained from the Secretary of the Society.

SECTION 6. Notice of the election, the filing requirements for the office of director and information as to how these may be fulfilled shall be announced in the annual premium list and twice in at least one newspaper of general circulation in Belmont County, Ohio, no earlier than six weeks and no later than two weeks before the election.

SECTION 7. The term of office of the retiring Directors shall expire and that of the Directors-elect begin at the October meeting of the Board of Directors.

## ARTICLE VI - ANNUAL MEETING OF MEMBERSHIP

SECTION 1. The annual meeting of the members of the Society shall be held at the appropriate site in Belmont County, Ohio, at the time fixed by the Board of Directors, which date shall not be later than November 30.

SECTION 2. At the annual meeting, the officers and directors of the Society shall make reports to the membership of the Society concerning the past fair and make recommendations for the betterment of future fairs. The members shall be given opportunity to make suggestions and recommendations for the improvement of the Society and its fair. Such other business may be presented as may be prescribed by this Constitution or as may be deemed proper by the Board of Directors.

# ARTICLE VII-ORGANIZATION AND MEETINGS

SECTION 1. The Board of Directors shall meet immediately following the annual meeting and elect by ballot a President, Vice President, Secretary and Treasurer to serve one year terms (beginning December 1 through November 30 each year) and until their successors are elected and qualified.

SECTION 2. All officers shall be members of the Society. The President and Vice President shall be directors. The Secretary and Treasurer may or may not be directors.

SECTION 3. Before the election of officers is conducted, the newly elected directors shall qualify by taking the following affirmation before a notary public: "I do solemnly affirm that I will support the Constitution of the United States, the Constitution of the State of Ohio, laws of Ohio and regulations of the Department of Agriculture of Ohio pertaining to Agricultural Societies and to the best of my ability perform the duties of Director of the Belmont County Agricultural Society, so help me God."

## **ARTICLE VIII - AMENDMENTS**

SECTION I. Amendments to the Constitution and By-Laws may be proposed by: (A) A majority of the vote of Directors at a scheduled meeting voting in favor of placing amendment on the ballot or (B) Filing a petition with the Secretary of the Society at least fourteen days prior to the annual meeting of the members of the Society. Said petition must set forth a proposed amendment and be signed by not less than twenty-five members of the Society.

SECTION 2. If an amendment is proposed, it shall be submitted to the membership of the Society at the annual meeting of the membership of the Society.

SECTION 3. When more than one amendment shall be submitted at the same time, they shall be so submitted as to enable the members to vote on each amendment separately. Amendments shall be published in at least one newspaper of general circulation in Belmont County, Ohio, not less than three or more than ten days before they are to be voted on.

SECTION 4. If the majority of the membership voting on the pro-

posed amendment shall adopt such amendment, it shall become a part of the Constitution and By-Laws.

#### **ARTICLE IX - COMPENSATION**

SECTION 1. The compensation of Board members shall be fixed by the Board in accordance with the rules of the Ohio Department of Agriculture.

#### ARTICLE X - FAIR DATES

SECTION 1. The Board of Directors shall set the dates for the annual exposition of the Society, subject to the approval of the Ohio Director of Agriculture.

#### **ARTICLE XI - ADOPTION OF RULES**

SECTION I. The rules governing the operation of County Agricultural Societies by the Ohio Department of Agriculture are hereby adopted. **BY-LAWS** 

#### **ARTICLE I - OUORUM**

SECTION 1. A majority of the members of the Board of Directors shall constitute a quorum for the transaction of business.

#### ARTICLE II - MEETINGS

SECTION 1. The regular meetings of the Board of Directors shall be held the fourth Thursday of each month at 8:00 p.m. unless changed by a majority vote of directors.

SECTION 2. Meetings may be held when necessary, at the call of the President or at the call of the Secretary upon the written request to Secretary by not less than nine members of the Board of Directors.

SECTION 3. All members of the Board of Directors shall be notified of meetings at least two days before the meeting. The notice need not specify the purpose of the meeting.

SECTION 4. All meetings of the Board of Directors shall be conducted according to Roberts Rules of Order.

ARTICLE III - ORDER OF BUSINESS

SECTION 1.

1. Call to Order, 2. Pledge of Allegiance, 3. Roll Call, 4. Reading and Approval of Minutes, 5. Treasurer's Report, 6. Accounts Payable, 7. Report of Committees, 8. Report of Officers, 9. Unfinished Business, 10. New Business, 11. Appointments, 12. Adjournment.

SECTION 2. The order of business may be temporarily suspended at any meeting upon a majority vote of the Board of Directors.

## **ARTICLE IV- DUTIES OF OFFICERS**

SECTION 1. It shall be the duty of the President to preside at all meetings of the Board, to appoint committees, and to perform such other duties as are determined by the Board.

SECTION 2. It shall be the duty of the Vice President to assume all duties of the President in the event of his absence or vacancy of office and to perform such other duties as are determined by the Board.

SECTION 3. It shall be the duty of the Secretary to: (1) Keep a list of all members of the Society; (2) Keep accurately a record of all proceedings of the Society and the Board; (3) Notify all members of the Board of the time and place of all meetings; (4) Give the members of the Society notice of the time and place of the annual election of the Board of Directors and the annual meeting of the membership; (5) Keep strict account of all moneys that may come into his hands and pay the same over to the Treasurer and take his receipt therefore; (6) Make out the annual report to the Ohio Department of Agriculture and (7) Perform such other duties as are determined by the Board.

SECTION 4. It shall be the duty of the Treasurer to: (1) Receive all moneys and give a receipt for the same as to amounts and sources from which it came; (2) Keep a correct itemized account of all receipts and expenditures of money; (3) Countersign with the President, Vice President or Secretary checks for payment of funds by the Society; (4) Verify that Treasurer's Books are reconciled with bank statements monthly; (5) Provide monthly financial statement for each Board meeting; (6) Assist Secretary with annual report to the Ohio Department of Agriculture; and (7) Perform such other duties as are determined by the Board.

## **ARTICLE V - RULES**

SECTION 1. The Board of Directors may enact Rules and Regulations for conducting the business of the Society as long as they do not conflict with their Constitution or By-Laws, regulations of the Department of Agriculture, or laws of the State of Ohio.

# **Open Class Rules and Regulations for Exhibitors**

#### ENTRIES

1. All exhibitors shall be required to have all open class entries in the hands of the Fair Secretary, Becky Selmon, P.O. Box 704 St. Clairsville, OH 43950 and fees paid by 5:00 p.m., Saturday, August 19, 2017. Entries may be made by mailing your entries and fees (postmarked on or before August 19, 2017) or in person at the Secretary's office on the fairgrounds from 9:00 a.m. to 5:00 p.m. on Thursday, Friday, and Saturday August 17, 18 and 19. Late entries will be accepted at the discretion of the Secretary or Department Superintendent if space is available.

2. All exhibitors must purchase a \$22.00 membership ticket (if a resident of Belmont County and age 18 or over) or a \$21.00 exhibitor ticket (if not a resident of Belmont County and/or under age 18). In addition, entry fees must be paid as listed in Department I, II and III.

3. Entries once entered upon the books of the Secretary cannot be withdrawn for the purpose of entering the same in another section or class or in the same section or class.

4. No refunds will be made on entries received.

5. Members of the same family will not be permitted to compete for the same kind of article without paying an additional entry fee.

6. Unless otherwise listed, no exhibit is to be entered in the name of any other than the bona fide owner.

7. None but the department superintendent(s) of the Belmont County Agricultural Society will be permitted to examine the books before premiums are awarded.

8. In order to protest an entry in either Open Class or Junior Fair, the following guidelines and procedures must be followed. (1) The protest must be submitted in writing to the Department Superintendent within 24 hours of action being protested. (2) Before any further action is taken, a \$50 deposit must accompany the written protest. (3) Immediate action will be taken after review of the protest first by Junior Fair Board of Directors (if a Junior Fair entry), then by the Belmont County Agricultural Society's Board of Directors Executive Committee and then by the Belmont County Agricultural Society Board of Directors for a final decision on the matter. (4) If protester is correct, the \$50 deposit becomes the property of the Belmont County Agricultural Society.

#### EXHIBITS AND JUDGING

1. Exhibitors shall receive from the secretary a card or cards containing the number and class for entries made. This card(s) is required before exhibits are placed on fairgrounds.

2. All livestock must be in place on the fairgrounds by 7:00 p.m., Tuesday, September 5, 2017. No animals or tack can be put in place before 5:00 p.m., Sunday, September 3, 2017.

3. All Domestic Arts, Horticulture and Grange exhibits must be in place by date and time listed in the rules of each department and/or section of the fair handbook.

4. Livestock entries may be removed from 12:00 midnight Saturday, September 9 to 10:00 a.m. Sunday, September 10. Any livestock remaining on the grounds at 10:00 a.m. Sunday, September 10 must remain on the grounds until 5:00 p.m. Sunday, September 10. All other exhibits, including commercial and concession displays, must remain in place until 5:00 p.m., Sunday, September 10.

5. Any exhibitor in open class or junior fair will forfeit premiums and be barred from exhibition at the fair the following year if exhibit removal time is violated without approval of the Belmont County Agricultural Society Board of Directors.

6. The Department Superintendents and Committees will take every precaution in their power for the preservation of all articles on exhibit after their arrival and arrangement on the grounds, but will not be responsible for loss or damage.

7. When there is but one exhibitor of several animals or articles in the same class, first, second, or third premium will be awarded according to the merit of the exhibit.

8. If animal or article is not deemed worthy of premium, the judge will not make the award.

9. The decision of the judge(s) is final.

10. It is the duty of the Superintendent of the various departments to assist the awarding committee in finding the articles on exhibition and see that none shall be overlooked.

# ADDITIONAL RULES AND REGULATIONS FOR LIVESTOCK EXHIBITS

1. No more than two entries per exhibitor in each of the single classes and no more than one entry per exhibitor in each of the group classes.

2. No entries will be accepted after sufficient entries to fill all stalls and pens have been received.

3. All exhibitors must give total head of livestock when making entries.

4. The Department Superintendents reserve the right to take measures prior to assigning entries to pens or stalls during the fair that may be deemed necessary to protect the health of livestock shown at the fair.

5. Registration papers must be available upon request.

6. No bedding will be provided.

7. Livestock entries for herds bred under one general management cannot be shown by two owners, nor can two different breeders combine their stock for one exhibit.

8. Any animal entered for exhibition in one class cannot compete for a premium in any other way except as one of a pair or herd.

9. No person other than the officers of the Society, judges, exhibitors of the stock and invited guests will be permitted to enter the ring where stock is being exhibited, and these will have places assigned them by the Department Superintendents.

10. The standard authority in all cases of pedigrees of livestock shall be the recognized "record" of such class or breed. All animals must be registered when shown for pure blood if they are of the proper age for registration.

11. The Belmont County Agricultural Society's Board of Directors reserves the right to test for drugs or disqualify any and all animals at their discretion at the 2017 Belmont County Fair.

12. All stalls are to be cleaned by the exhibitor following the removal of the animals.

13. Any violation of these regulations will forfeit premiums.

14. Entry fees are as follows: \$5.00 per class for all beef and dairy cattle and \$2.50 per class for all goats except for championship classes.

15. Five (5) Single Day Passes will be issued to each livestock exhibitor who exhibits 5 or more animals.

16. All Inspection and Health Requirements of Livestock Exhibited in Ohio apply.

#### INSPECTION AND HEALTH REQUIREMENTS OF LIVESTOCK EXHIB-ITED IN OHIO

NOTE: A REVISED LIST OF INSPECTION AND HEALTH REQUIRE-MENTS FOR 2017 IS AVAILABLE FROM THE FAIR SECRETARY UPON REQUEST.

#### 901:l-18-01 Chapter's Application

(A) Animals listed in this chapter when moved or imported into Ohio for exhibition purposes only shall comply with the requirements of this chapter and when in compliance with the provisions of this chapter shall, with the exception of rules governing movement and importation of quarantined animals, be exempt from any other rules governing movement within or importation into Ohio.

(B) Animals moved within or imported into Ohio for any purpose in addition to exhibition shall meet all movement and import requirements of Chapter 901:1-17 of the Administrative Code.

#### 901:1-18-02 Definitions

As used in this chapter:

(A) "Exhibition" means any public show of animals which is sponsored by or under the control of an Ohio county or independent agricultural society organized under chapter 1711 of the Revised Code; or the Ohio State Fair; or which is assembled for a period which exceeds thirty-six hours or contains animals of origins other than Ohio.

(B) "Certificate of Veterinary Inspection" means a form from the state of origin which has been issued and completed by a licensed and accredited veterinarian attesting to the health status and identification of an animal listed thereon.

(C) "Approved Veterinarian" means any licensed and accredited veterinarian approved by the Ohio Department of Agriculture, or an employee of the Ohio Department of Agriculture or the United States Department of Agriculture, Animal Plant Health Inspection Service, Veterinary Services.

(D) "Licensed and Accredited Veterinarian" means a person who is licensed by the state of Ohio to practice veterinary medicine and who is certified by the United States Department of Agriculture, Animal Plant Health Inspection Service, Veterinary Services, to be an accredited veterinarian.

(E) "Residue" means poisonous or deleterious pesticide governed by 40 C.F.R. 180, any poisonous or deleterious substance governed by 21 C.F.R. 109.6 or any other substance governed by 21 C.F.R.556.

(F) "Contagious or infectious disease" means any disease, including any foreign animal disease, or vector, capable of transmission by any means from a carrier animal to a human or to another animal and includes dangerously contagious or infectious diseases.

(G) "Tuberculosis accredited free herd" is one that has passed at least two consecutive annual negative official tests for tuberculosis in accordance with the "Uniform Methods and Rules – Bovine Tuberculosis Eradication", and has no other evidence of bovine tuberculosis.

901:1-18-03 Exhibitions:

Sanitation, Inspection and Records (A) Each entity sponsoring an exhibition shall have in attendance an approved veterinarian for the duration of the exhibit.

(B) Each entity sponsoring an exhibition shall:

(1) Immediately, prior to an exhibition and under the direction of the approved veterinarian, thoroughly clean and disinfect each building, pen, stall, ring or other enclosure in which animals are to be quartered for exhibition;

(2) Have the approved veterinarian:

(a) Examine the certificate of veterinary inspection when required for an animal brought to the exhibition;

(b) Inspect within a reasonable time of arrival each animal brought to the exhibit for symptoms of any infectious or contagious diseases;

(c) Daily inspect each animal present at the exhibition for symptoms of infectious or contagious disease.

(3) Maintain a record for one year from the date of the exhibition of each animal present at the exhibit. The record shall contain the name and address of the owner of each animal and the species and breed of the animal.

(4) May order the immediate removal of any animal which in the opinion of the approved veterinarian places other animals at unacceptable risk of disease.

(C) An exemption from the requirements of paragraph (B)(1) of this rule may be requested from the department and will be granted when, in the judgment of the department, cleaning and disinfection will serve no purpose. By way of example only, cleaning and disinfection will generally serve no purpose in a newly constructed building that has never been occupied.

#### 901:1-18-04 Exhibitors

(A) No person shall present for exhibition or exhibit an animal which he knows or has reason to suspect is affected with or has been exposed to a dangerously contagious or infectious disease or residue.

(B) The owner or bailee of an animal with symptoms of an infectious or contagious disease shall, when directed by an exhibition official, the approved veterinarian, or an employee of the Ohio Department of Agriculture, immediately remove the animal from the exhibition premises.

(C) Upon request, each person who presents for exhibition or exhibits an animal, shall make available any certificate of veterinary inspection, registration certificates, vaccination certificate, and other documents to exhibition officials, the approved veterinarian or an employee of the Ohio Department of Agriculture.

(D) Each person who presents for exhibition or exhibits an animal for which a certificate of veterinary inspection is required by rules 901: 1-18-01 to 901:1-18-11 of the Administrative Code shall forward a copy of the certificate of veterinary inspection to the Ohio Department of Agriculture's Division of Animal Industry.

901:1-18-05 Poultry and Fowl

(A) All turkeys, chickens and game birds moved within or imported into Ohio for exhibition must:

(1) Originate directly from a flock or hatchery which is a participant in the national poultry improvement plan for the eradication of disease and be accompanied by documentary evidence that they meet the requirements of this paragraph; or (2) Originate directly from a flock which has had a negative test for pullorum/fowl typhoid disease within twelve months preceding the opening date of exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or

(3) Have had a negative test for pullorum/fowl typhoid disease, within ninety days, preceding the opening date of the exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or

(4) Be tested for pullorum/fowl typhoid disease upon arrival at the exhibition by a tester approved by the Ohio Department of Agriculture and found negative.

(B)The rapid whole blood test shall not be used to test turkeys for compliance with the requirements of paragraphs (A)(2), (A)(3) and (A) (4) of this rule.

(C)Waterfowl, doves and pigeons are exempt from this rule.

901:1-18-06 Cattle

(A) Cattle moved within Ohio for exhibition:

(1) The animals presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.

(B) All cattle imported into Ohio for exhibition must:

(1) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition;

(2) Originate from a tuberculosis-accredited free herd, an accredited free state or zone, or a modified accredited advanced state or zone;

(3) If originate from a modified accredited state or zone must comply with Rule 901:1-17-03 of the Administrative Code;

(4) If originate from an accreditation preparatory or a non-accredited state or zone are prohibited from exhibition;

(5) If from a brucellosis class A state or area/zone must be negative to an official brucellosis test within thirty days of the opening date of the exhibition unless: they are under six months of age, steers, or official vaccinates under twenty months of age (dairy) or twenty-four months of age (beef); and

(6) If from a brucellosis class B or C state or area/zone must meet all requirements for pre-entry testing as specified in 9 C.F. 78.9 and obtain an Ohio permit prior to movement.

(C) Cattle from a brucellosis certified free herd or class free state or area/zone are not required to be brucellosis tested.

#### 901:1-18-07 Goats

(A) Goats moved within Ohio for exhibition: The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.

(B) Goats imported into Ohio for exhibition;

(1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition;

(2) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease; and

(3) The owner and the veterinarian must attest to the following statement written on the certificate of veterinary inspection, "the goats in this shipment are not know to be under any movement restrictions because of "scrapie."

(4) Originate from a tuberculosis accredited free herd as defined in rule 901-18-02 (G) of the Administrative Code for bovine tuberculosis eradication; or

(5) Originate from a bovine accredited free state or zone, or a bovine modified accredited advanced state or zone; or

(6) Originate from a bovine modified accredited state or zone must comply with Rule 901:1-17-06 of the Administrative Code.

(C)If originate from a bovine accreditation preparatory or a bovine non-accredited state or zone are prohibited from exhibition.

(See additional information at end.)

901:1-18-08 Horses, Mules and Ponies

(A) Horses, mules and ponies moved within Ohio for exhibition:
 (1) If not under quarantine and if they are free of any signs of a contagious or infectious disease; and
 (2) If the animal is twelve months of age or older, the exhibition manager may require that

the animal has been tested and classed negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition.

(B) Horses, mules and ponies imported into Ohio for exhibition:

Belmont County Fair Book

(1) Shall be accompanied by an official certificate of veterinary inspection issued within thirty days of the opening date of the exhibition or obtain a permit for extended time granted by the chief of the division of animal industry as authorized in paragraph (C) of rule 901:1-17-01 of the Administrative Code; and

(2) If the animal is twelve months of age or older, it shall be accompanied by evidence the animal was negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition; and

(3) Upon request by an authorized representative of the Ohio Department of Agriculture, the person responsible for each animal must make available a chronological list of dates, places and events attended by this animal within thirty days prior to entry into Ohio.

## 901:1-18-09 Sheep

(A) Sheep moved within Ohio for exhibition: The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.

(B) Sheep imported into Ohio for exhibition:

(1) Must be accompanied by a certificate of

veterinary inspection issued within thirty days preceding the opening date of the exhibition; and

(2) The animal presented for exhibition must show

no symptoms or evidence of an infectious or contagious disease; and (3) The owner and the veterinarian must attest to

the following statement written on the certificate of veterinary inspection "the sheep in this shipment are not known to be under any movement restrictions because of "scrapie." (See additional information at end.)

## 901:1-18-10 Swine

(A) Swine moved within Ohio for exhibition:

(1) At a terminal show must: We are a partial terminal show.

(a) Show no symptoms or evidence of an infectious or contagious disease; and

(b) Originate from a county which sixty days prior to the exhibition opening date had no pseudorabies quarantined herds; and

(c) Have no breeding swine present and all swine removed are delivered for immediate slaughter or to a licensed livestock facility.

(d) Notwithstanding any other provisions of these rules, the manager or sponsor of the exhibition may, prior to permitting the exhibition of any porcine animal at a terminal show require proof, for example a VS form 4-33, animal disease diagnostic laboratory submission form, or a certificate of veterinary inspection, the animal has been tested and classed "negative" to an official test for pseudorabies within forty-five days immediately preceding the opening date of the exhibition.

(2) At all other shows, must be accompanied by a certificate of veterinary inspection issued within forty-five days preceding the exhibition opening date; and must be negative to an official pseudorabies test within forty-five days of the exhibition opening date unless:

(a) They originate immediately and directly from a pseudorabies qualified herd; or

(b) Are suckling pigs accompanying a negative dam; or

(c) They originate from a pseudorabies vaccinated herd and meet the following conditions:

(i) The herd has had a negative monitored test within twelve

months, and

(ii) The swine presented for show are negative to a pseudorabies differential test; or

(3)Will be exempt from the requirement of a certificate of veterinary inspection if they originate immediately and directly from a stage V area and show no symptoms or evidence of an infectious or contagious disease.

(4) Are exempted by a written permit issued by the department.

(B) Swine imported into Ohio for exhibition:

(1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the exhibition opening date; and

(2) Be negative to an official pseudorabies test within thirty days of the exhibition opening date unless:

(a) They originate immediately and directly from a stage V area or from an area or country recognized by the United States Department of Agriculture, Animal Plant Health Inspection Service, Veterinary Services as pseudorabies free; or

(b) They originate immediately and directly from a pseudorabies qualified herd and have not been previously exhibited this show season; or

(c) Are exempted by a written permit issued by the department.

(C) Swine moved within or imported into Ohio for racing shall:

(1) Be separated at all times from any other swine on the exhibition grounds by the greatest distance reasonably possible; and

(2) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition; and

(3) Be negative to an official pseudorables test within thirty days of the exhibition opening date unless:

(a) They originate immediately and directly from a stage V area or from an area or country recognized by United States Department of Agriculture, Animal Plant Health Inspection Service, Veterinary Services as pseudorabies free; or

(b) They originate immediately and directly from a pseudorabies qualified herd and have not been previously exhibited this show season;

(c) Are exempt by written permit issued by the department.

(4) Be exempt from the immediate slaughter requirement of paragraph (A)(c) of this rule.

#### 901:1-18-11 Llama

(A) Llama moved within Ohio for exhibition when presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.

(B) Llama imported into Ohio for exhibition:

(1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the exhibition opening date.


(2) When presented for exhibition must show no symptoms or evidence of contagious disease.

CHAPTER 901-19 OF THE ADMINISTRATIVE CODE (OHIO'S LIVESTOCK TAMPERING EXHIBITION RULES) WILL BE MADE AVAILABLE TO A LIVESTOCK EXHIBITOR OR ADULT ADVISOR UPON REQUEST.

#### SHEEP AND GOAT, EXHIBITION REQUIREMENTS

From The Ohio Department of Agriculture 2-21-02

In order for Ohio to maintain Consistent State Status, Ohio sheep and goat exhibitions will be considered Interstate Commerce.



A. Requirements for bringing sheep and goats into Ohio for exhibition, sale or breeding

1. Certificate of Veterinary Inspection (CVI) issued within 30 days of the opening date of the exhibition.

2. CVI must be signed by the owner and the veterinarian attesting to the following statement: "the sheep/goats in this shipment are not known to be under any movement restrictions because of "scrapie."

3. Show no evidence of infectious or contagious disease.

4. All sheep and goats must be identified with

official USDA identification (USDA approved sheep tags, USDA approved tattoos, or identification in the Scrapie Flock Certification Program)

5. If the animal was born after January 1, 2002,

it must have official USDA sheep/goat identification and be identified to the flock of birth.

A. Identification requirements for sexually intact

sheep and goats moving within Ohio for exhibition including sales 1. Official USDA sheep/goat identification in the form or an approved tag or tattoo

2. If the animal was born after January 1, 2002, it must have official USDA sheep/goat identification and be identified to the flock of birth by an eartag or tattoo placed by the owner of the flock of birth, or a tag or tattoo placed by the purchaser.

3. The identification requirements for flocks enrolled in the Voluntary Scrapie Flock Certification Program qualify as official USDA identification for exhibition and interstate movement; no other special identification is needed.

Ohio sheep and goat wethers that are less than 18 months of age exhibited in Ohio do not require USDA identification.

B. "Exhibition" means any public show of animals which is sponsored by or under the control of an Ohio county or independent agricultural society OR the Ohio State Fair OR which is assembled for a period which exceeds 36 hours OR contains animals of origins other than Ohio.

- Includes show lamb and goat sales, consignment sales of livestock and jackpot shows

D. Responsibilities of an exhibition sponsor (includes show

lamb and goat sales, consignment sales of livestock and jackpot shows):

- 1. Must have an approved veterinarian
- Buildings, pens, stalls, rings and other enclosures in which animals are to be quartered for exhibition must be cleaned and disinfected prior to the exhibition under the direction of the approved veterinarian.
- 3. The approved veterinarian is required to:
  - a. Examine CVI when required; and b. Inspect livestock for infectious or contagious
    - diseases within a reasonable time of arrival; and c. Inspect livestock daily.
- May order the immediate removal of any any animal which, in the opinion of the approved veterinarian, places other animals at unacceptable risk of disease.
- Maintain a record for one year from the date of the exhibition of each animal present at the exhibit. Sheep and goat sale records must be kept for 5 years. (see (F) below)

E. For livestock purchased at an exhibition and moved out of state, an accredited veterinarian must issue a certificate of veterinary inspection before the animal moves across the state line.

F. The Code of Federal Regulations requires that sheep and goat sale records be kept for 5 years by the seller, the buyer and the exhibition/sale sponsor. The records must contain the following information:

- 1. Name and address of the seller, telephone number if available; and
- 2. Name and address of the buyer, telephone number if available; and
- Official identification when required as indicated in Part A and B of these requirements; and
- 4. Date of sale.



## 2017 \* EVENT RULES AND REGULATIONS \*2017

Entry Fee – \$30.00 Car Pit Passes – \$10.00 Per Person

In the interest of safety, Drivers and Mechanics are subject to, and must obey, the following rules and regulations which are set up by the promoter and the track where this event is being held.

1. Each driver must sign and fill out an entry blank at the registration desk the day of the show.

Every driver must have their driver's license at the time of registration, NO EXCEPTIONS. Every driver must have their car inspected at least one hour prior to show time, or a \$10.00 late fee may be imposed.

2. All drivers must supply their own cars, only one entry per person. Proof of ownership may be required on each car entered.

3. All drivers and/or pit persons 16 or 17 years of age must have a notarized release signed by his or her parent or guardian. Nobody under 16 years of age can drive or be in pit area.

4. All persons must sign the release sheet and receive a pit pass to be permitted in the pit area or on the track. Drivers only to receive a free pit pass upon registration; all other pit passes \$10.00.

5. The track or promoter reserves the right to approve or reject any and all entries.

6. ALL CARS will be inspected, so be LEGAL ...

7. No drinking of alcoholic beverages is permitted on fairgrounds including on track, in the emergency vehicle area, or in the pit area. Any driver or pit person under the influence of alcohol or drugs will be immediately disqualified and removed from the grounds.

8. Any driver or crew member disobeying the rules will cause his or her car to be disqualified. Non-sportsman like conduct will not be tolerated and will be grounds for disqualification and barring from the future derbies. Drivers are responsible for the actions of their crew members.

9. All drivers must get out of their car for inspections. In addition, drivers must get out of their car when being inspected after heat and feature.

THE DERBY WILL BE COMPOSED OF INDIVIDUAL HEATS AND ONE FEATURE WITH CASH PRIZES GOING TO THE WINNERS OF EACH HEAT AND A GRAND PRIZE GOING TO THE WINNER OF THE FEATURE. DECISIONS OF THE OF-FICIALS ARE FINAL.

### RUNNING

1. Safety belt, helmet, and goggles/safety glasses/face shields are RE-QUIRED.

2. Pants of some kind, no shorts allowed. YOU WILL NOT RUN IF YOU HAVE SHORTS ON!!!

3. Sand Bagging and Teaming will not be tolerated.

4. Separation of stuck cars at discretion of officials. (Safety reasons or last (2) two cars running.)

5. No deliberate head-on collisions and no deliberate driver's door collisions.

6. Vehicle must have dependable brakes at all times and boundaries must be observed.

7. No cars permitted in the competitions area before the heat in

which they are to participate.

8. A vehicle will be disqualified if the driver's door comes open during the heat.

9. One minute limit is enforced by the track officials for re-starts and making competitive contact with another car. Hits must be aggressive. Simple contact within the time limit does not constitute combat and could be considered sand bagging.

10. All cars are to be removed from the fairgrounds or race track following the show or they will become the property of BCAS and the officials will have them removed. (Unless otherwise specified at driver's meeting, a removal deposit may be required in some areas.)

11. A \$50.00 protest fee is required to contest another car. Protest must be made by another driver. No protests allowed after the drivers meeting.

12. No riding on outside of cars anytime due to insurance regulations.

13. Boundaries must be observed at all times. Any car, shoved or driven out of bounds, or on or over a post or tire, may be immediately disqualified if Derby officials feel it is a safety hazard.

14. One warning on driver's door hit, second hit will result in disqualification.

## BUMPERS

No special bumpers, reinforcements or trailer hitches permitted. Fender and bumper end may be trimmed to allow for tire clearance, bumper maximum 25" from bottom of bumper. Welding on front or rear bumper shock is permitted. No bolting sheet metal to bumpers. Welding front/rear bumper is permitted. Do not over weld bumpers or brackets. 1" wide welds on bumper shocks and brackets.

**SUSPENSION** 

Cars with torsion bars may turn up. No locked suspension. No welding. May use spring block in coil springs. May weld top and bottom of coil spring to hold in. No putting leaf springs under coil spring cars. Any type tires permitted. Stock rear ends only. 5 –lug Ford in Ford, Chevy in Chevy, etc. Any type motor and transmission permitted. Leaf spring cars must have stock springs. No engine cradles. No distributor protectors. No welded wheels. Slider drive shafts permitted. CHASSIS – FRAME

No welding frame seams – no exceptions. Welding motor or transmission mounts are permitted. Welding rear end gears are permitted. No tiling of frames. No hump plates. Compact wheel base 113" from center hub to center hub. Leaf spring cars will have stock leaf springs only.

## BODY

Factory body mounts only. No welding of body seams other than the driver's door. <sup>1</sup>/<sub>4</sub> inch -4 inch wide you may weld a 3 inch x 3 inch place <sup>1</sup>/<sub>4</sub> inch thick on rest of doors two spots per door, seam or band or wire. Bar across dash behind seat and door and halo bar are recommended. Roll cage must be sheet metal only with nothing to frame. Gas tank protector 24 inches wide. Not to be welded or bolted to floor. Must come off rear bar. No wedging, crimping or tucking of fresh cars. Body panels must be in stock position. No rolling sheet metal. Pre-run cars may be wedged. No bolting body panels.

## **TRUNKS AND HOODS**

May be banded or wired in 6 places to frame or bumpers. No welding washers to body to run banding or wire, only 3 strands per hold of No. 9 wire. Trunks and hoods may be banded or wired shut before inspection 12 inch hold center of trunk must be 12 inch hold in hood or header holes. No welding on hood or trunk.
